Dear ICAN Partners and Friends,

April, Child Abuse Prevention Month, brought an important focus on our county's commitment to preventing child abuse and neglect. Key issues we have identified as critical to increasing accountability for children's safety were recognized, as well as tangible steps for our public and private efforts to prevent harm to children.



The Board of Supervisors unanimously approved a Proclamation of Child Abuse Prevention Month on April 19th, recognizing the professionals and volunteers who work to promote the safety, joy and well-being of children and families.

The Board motion supported our ICAN sponsored AB 2654 (Lackey) to reconvene the State Child Death Review Council. This will promote development and coordination among child death review teams throughout the state. The CEO and DCFS will be working with ICAN on two ICAN Associates

Every year, hundreds of children participate in the Poster Art contest, which provides them the opportunity to express their ideas and concerns regarding child abuse and neglect. The Board Motion created a scholarship fund for children who may be unable to participate in this contest because their schools lack art supplies.

Perhaps most importantly, this Motion declared Los Angeles County to be a No Hit Zone with instructions to all county agencies to post No Hit Zone posters, and share brochures and information on positive alternatives to discipline with families they serve.

Here is why the No Hit Campaign is important. It can promote a culture of non-violence, and it can save lives. Over half of the child fatalities documented in ICAN's 30 year study of child homicides involved physical trauma to very young children. Sadly, these tragedies can result from over-discipline for normal childlike behavior. Moreover, research shows that hitting is not an effective means of improving children's behavior. On the contrary, it teaches them that hitting is the way to express anger.

Much as our culture has changed behavior by recognizing the negative effects of smoking, we can change behavior with a message that hitting is hazardous to our social and physical health. ICAN is focusing on preventing child abuse, but the no-hit message applies to inter-personal violence and bullying as well.
